Dear Commissioners,

I am the owner of the property 31 Bayshore Cir. on Palm Island, Placida, FL 33946.

This letter is to express my sincere concern about Environmental Utilities, LLC (EU) being approved to install a sewer system on Palm Island.

There are several reasons which cause my concern:

- The EU presented connection fees which are not based on detailed calculations but seem rather to be of rough estimation. Once installed, the sewer connection fees could be raised significantly, well beyond any reasonable amount. Then, there is the monthly usage cost which is said to be \$178.78. Adding the cost for water which is \$100 a month, one has to pay about \$280 a month for water and sewer. That is about **three times** the amount our neighbors in Rotonda are paying.
- There was no scientific research demonstrating the need for service based on environmental impact.
- The applicant (EU) does not have the financial resources necessary to install such an elaborate sewer system.
- The applicant (EU) does not possess the technical expertise to design and oversee/lead/conduct the installation of such an involved sewer system (no ability to use of gravity and the need to cross the ICW). EU never designed or installed a sewer system.

As a resident, I have yet to meet even one supporter on this island who supports EU's interest in developing this project, only consternation and concern.

Based on the foregoing, I request that the PSC denies the application of EU for wastewater service.

I am writing this email in opposition to EU 's proposal for sewer on Little Gasparilla Island (LGI) I do not feel that there is a proven need for this system to be installed on the island. The current houses on the island all have septic tank and drainfields. As they fail/if they fail?when they fail and need replacement the the county health has very stringent policy's and procedures that have to be met. Most people/ owners/ on the island take care of there systems so that they do not fail. A septic system, like any other part of a home needs maintenance to keep it in working order. My particular property is inspected and maintained on an annual basis.

I have never requested the installation of a central sewer system. I have always preferred septic systems to central sewer systems in my homes. This system will shut down when the power goes out or we will be plagued with the cost and noise of generators. If it shuts down in the storm what did it accomplish?

The cost of the system is huge. We all pay big time property taxes already. We pay a large fee just to have water available. I have a 2 bedroom home and the monthly fee is \$74.00 per month before I use one drop of water. I use a minimal amount of water about \$5.00 a month worth so the availability fee is not proportional. If this is for water can you imagine the fee for sewer? I do not believe that EU has the technical expertise to run this type of sewer system. When the water lines were run the lines were not installed in the proper easements. So where are the sewer lines going to be installed. When I questioned Mr. Boyer (sic) about he said "well this is where the previous owner said to put the line" that is not a correct answer. The utility lines should have been put in the utility easement. I have installed many energy efficient items on my house since I purchased it , incldung solar panels and battery back up. This allows me to ride out the power outages with no loss of food, etc. the sewer system will not run on my poser so if there is a power outage I would be forced to vacate my home due to the toilets/etc not working.

Dear Clerk and Commissioners,

My husband, George Shopp and I own the property at 9866 Little Gasparilla Island. We are writing to request that you deny Environmental Utilities' application for Original Certificate of Authorization for the proposed sewer system (Docket 20200226).

After reading expert testimony, it is not clear to me that degree of pollution from septic systems warrants installation of a sewer system.

I wonder if the potential environmental benefits of the proposed sewer system would be worth the disruption to the island. Numerous turtles, birds and other animals nest where the power lines run through our property (which I assume is where EU proposes accessing our property). We looked into burying power lines 5 years ago and one thing FPL told us that the turtle nest would need to be relocated at a cost of \$3000 per nest.

Is it known whether certain septic systems are causing problems and others aren't? Perhaps it would make more sense to assess the status of septic systems on the Island to ensure they are compliant. If it turns out we do need a sewer system, I would not entrust the planning and installation of a sewer system to a private company. What is the reasoning behind using a private company with no experience? Can the county take on this responsibility?

I have not seen any plan for the type of system or its installation. This will be a unique job and require expertise. It is my understanding that EU has no experience with sewer systems.

Dear Commissioner Clark:

I am writing to formally request that you deny EU's application for wastewater service to Palm Island in Charlotte County. I am a property owner within the proposed service area of Palm Island at 421 Kettle Harbor Drive, Placida. This is a small barrier island with mostly second homes that are unoccupied by owners or renters a large portion of the time. It is a rural area where owners make environmental conservation and wildlife preservation a high priority. As a rural area,

Charlotte County has discouraged central sewer system infrastructure that would promote higher density residential or commercial development. We have a large gopher tortoise population and a thriving sea turtle nesting season that would be jeopardized by overdevelopment and potentially by large scale machinery brought in to run sewer pipes, install holding tanks, and crush existing septic systems. To my knowledge, there have been no studies of the water quality in this service area that prove contamination from the current septic systems. The county ordinance requires inspection and pumping of septic system at regular intervals and there have been no documented septic system failures. There is no guarantee that conversion to a sewer system will eliminate nitrate and phosphate contamination, as evidenced by the contamination documented in Rotunda. There is also the risk of a sewage leak into surrounding waterways which would be more catastrophic than an isolated septic system failure.

Until the need for conversion from septic to sewer on Palm Island is supported by water quality testing, I do not see the rush to grant EU permission to develop a private sewer system. I have not seen any concrete data showing the feasibility and cost of such a project. I do not believe EU has the technical expertise to undertake a sewer project. I strongly believe that if such a project is deemed necessary for environmental reasons, that it should be constructed and managed by Charlotte County, not a private company that has not determined costs of hook-up and maintenance and that will not be regulated to ensure that we Charlotte County residents will be charged fair and equitable rates as compared with other residents of the county. In addition, it is my understanding that the pump requires electricity, which is frequently disrupted on this island for long periods of time. This could cause sewage back-up. Disruption of the existing septic tanks on the island may require destruction of mature landscaping which in turn will affect wildlife on the island. I am also against the easement EU has requested that would go from the sewer equipment close to my home to the road. I have strong concerns regarding EU's ability to provide emergency service for sewer system issues, particularly on a barrier island only accessible by ferry from 6:30 am to 10 pm. Please, before rushing into such a large project with a private company without experience in sewer system construction, deny EU's application for wastewater service until you are presented with more data showing the need for such service and the cost for the installation and maintenance of such service.
