Re: Notification of Assignment of Interconnection, Collocation and Resale Agreement for the State of Florida with Embarq Florida, Inc. d/b/a CenturyLink from Hargray of Tallahassee LLC (TY202) to Metro Fibernet, LLC d/b/a MetroNet (TY173)

Dear Mr. Teitzman:

Hargray of Tallahassee LLC (“HOT”) hereby respectfully notifies the Florida Public Service Commission that its existing Interconnection, Collocation and Resale Agreement (the “Agreement”) for the State of Florida with Embarq Florida, Inc. d/b/a CenturyLink (“CenturyLink”) is being assigned to Metro Fibernet, LLC d/b/a MetroNet (“MetroNet”) in connection with the pending transfer of HOT’s assets and customers to MetroNet.¹ CenturyLink has consented to the assignment of the Agreement as explained herein.

In Docket No. 20110234-TP, the Commission approved a request filed by Electronet Broadband Communications, Inc. (“Electronet”) to adopt the Interconnection, Collocation and Resale Agreement for the State of Florida, dated March 20, 2007, by and between NuVox Communications, Inc. and CenturyLink (the “Electronet Agreement”). In Docket No. 20200045-TP, the Commission approved a request filed by Hargray of Florida, Inc. (“HOF”) to adopt the

Electronet Agreement in connection with HOF's acquisition of Electronet's assets and customers (the "HOF Agreement"). HOF later assigned the HOF Agreement to its affiliate HOT in connection with an internal corporate reorganization pursuant to which HOF's customers and assets in and around the Tallahassee area were transferred to HOT.²

As explained in the February Notice, HOT is transferring certain customers and assets to MetroNet, including certain customer accounts and receivables, certain customer agreements and contracts, certain vendor agreements and contracts, and certain equipment in and around the Tallahassee area (the "Transaction"). The Agreement is being assigned to MetroNet in conjunction with the Transaction. The Transaction is expected to close after March 31, 2022.

CenturyLink has consented to the assignment of the Agreement to MetroNet. CenturyLink's consent is effective as of the date of consummation of the Transaction. If the closing of the Transaction does not occur for any reason, the Agreement will remain with HOT, and CenturyLink's consent shall be null and void and of no force or effect.
