Re: Sunshine Water Services Regulatory Assessment Fee (RAF) return form consolidation

Dear Mr. Deason:

After several internal meetings beginning in January of this year, Commission staff has developed a method for the Florida Public Service Commission (Commission) to accommodate your request to consolidate required regulatory assessment fee (RAF) forms and payments for Sunshine Water Services (Sunshine or Company).

As you explained in your initial request on January 5, and in subsequent conversations with staff during that same month, there were changes within your Company resulting in a shift of responsibility for preparing and filing the RAF forms and RAF payment. You expressed concern that there were approximately 18 RAF forms to be filed, a separate RAF form for each water and wastewater system associated with the 14 existing PSC Company Codes assigned to Sunshine. Your specific request was that our Agency reduce the number of required RAF forms from 18 separate forms to a single water RAF form and a single wastewater RAF form, both of which would include water/wastewater revenue for all of the Company's water and wastewater systems, respectively and would be submitted as a Class A utility twice a year.

In response, the Division of Administrative and IT Services (AIT) will need to effect a single Company Code for Sunshine, to be used within our RAF database and RAF system. AIT has instructed that the single code should be one of the 14 existing codes currently assigned to Sunshine.

Based on our March 21, 2022 conference call with you, the single Company Code agreed to be used for this purpose is WS251. This Company Code will be used as the reference Company Code for RAF filings for Sunshine on a going-forward basis for all of the Company's systems.



Furthermore, as the Company is consolidated for ratemaking purposes, all of Sunshine's systems will be included in the RAF forms mailout in June and December of each year, with forms and payments due July 30 and January 30, respectively, per Rule 25-30.120(2)(a), F.A.C.

As a reminder, while we will be issuing consolidated RAF forms for Sunshine, the Company must continue to comport with the specific accounting requirement of Order No. PSC-2017-0361-FOF-WS (Page 226) regarding maintenance of ungrouped accounting records for its individual systems.

We are happy that we have been able to accommodate your request for a consolidated RAF form/payment on a going-forward basis, starting in June 2022. If you have any questions, please don't hesitate to contact Cissy Galloway at 850-413-6922.
