On April 4, 2022, pursuant to Section 366.093, of the Florida Statutes (F.S), and Rule 25-22.006, Florida Administrative Code., Duke Energy Florida (DEF or Company) requested an extension of confidential classification for certain information contained within the documents produced by DEF in response to the Office of Public Counsel's (OPC) First Request to Produce Documents (Nos. 1-13) as well as portions of both DEF's responses to OPC's First Set of Interrogatories (No. 1-25), and portions of the interrogatories themselves, in the above-referenced docket, dated May 20, 2020. The material that is the subject of this confidentiality request appears in Document No. 02693-2020 and is cross referenced to Document Nos. 02723-2020 and 02830-2020.

On June 8, 2020, DEF filed the original Request for Confidential Classification related to these documents. DEF's Request was granted by Order No. PSC-2020-0356-CFO-EI on October 9, 2020.

The Company is claiming confidentiality for certain information contained within the documents produced by DEF in response to the Office of Public Counsel's (OPC) First Request to Produce Documents (Nos. 1-13) as well as portions of both DEF's responses to OPC's First Set of Interrogatories (No. 1-25), and portions of the interrogatories themselves, under Section 366.093(3), F.S. Per the Statute, propriety of confidential business information includes, but is not limited to: Subsection (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." The information provided in the aforementioned response for which confidential treatment is being sought can be described as information revealing vendor-specific information related to DEF's request for information and request for proposal process.

Staff has reviewed the information contained within the documents produced by DEF in response to the Office of Public Counsel's (OPC) First Request to Produce Documents (Nos. 1-13) as well as portions of both DEF's responses to OPC's First Set of Interrogatories (No. 1-25), and portions of the interrogatories themselves, as well as the Company's confidentiality request. In staff's opinion, the information that is the subject of the confidentiality request does meet the criteria for confidentiality

contained in Section 366.093(d) and (e) F.S. Therefore, staff recommends that the request for extension of confidentiality of the information included in Document Nos. 02693-2020, 02723-2020, and 02830-2020 be approved.
