1	PROCEEDINGS
2	CHAIRMAN FAY: With that, Commissioners, we'll
3	be taking up our last item agenda in the conference
4	today. Item 5. Mr. Cicchetti, you're getting
5	yo-yo'd today. We've got you up and down, up and
6	down. I appreciate your patience.
7	With that, I know this is similar to some of
8	the other items. If you want to provide a brief
9	presentation of the item.
10	MR. CICCHETTI: Yes. Item 11 addresses Duke
11	Energy Florida's treatment of excess deferred
12	income taxes
13	CHAIRMAN FAY: Just for clarification. I'm
14	sorry, Mr. Cicchetti. Item 5, correct?
15	MR. CICCHETTI: Item 5 addresses the change in
16	the state corporate income tax rate in 2021 for
17	Duke Energy Florida. Changing the state corporate
18	income tax rate produced a slight revenue
19	requirement increase for Duke Energy Florida for
20	2021 of approximately \$98,000. The company has
21	elected to forego the revenue requirement increase.
22	Staff recommends approval.
23	CHAIRMAN FAY: Great. Thank you, Mr.
24	Cicchetti. With that, Commissioners, I have one
25	question. I'm also happy to take any questions or

1	discussion from any of you. Mr. Cicchetti, so the
2	recommendation talks about the deficiency being
3	foregone by the utility. If they have chosen to do
4	that now, because of that, is there another
5	mechanism that they're able to recover that later,
6	or if they forego it, that's their opportunity?
7	MR. CICCHETTI: If they forego it, that's
8	their opportunity. The settlement agreement
9	provides this forum in order for them to consider
10	that. So they won't be collecting somewhere else.
11	CHAIRMAN FAY: Okay. Great. Thank you. And
12	then just my last question. I don't remember how
13	many of these we took up initially, but I know
14	because of some of the tax changes we've had a
15	number of dockets that have addressed this. Do we
16	have more of these coming? And I guess if there
17	are tax changes in the future this might require
18	a little speculation but would we likely see
19	these opened back up or see new dockets opened back
20	up, or would they be resolved from the settlement?
21	MR. CICCHETTI: This solves resolves the
22	tax dockets that had been opened before the
23	Commission. If there's a future change in the tax
24	rate, federal or state, new dockets will be open to
25	address them.

1	CHAIRMAN FAY: Okay. Great. So this is the
2	last one, as far as the previous changes?
3	MR. CICCHETTI: Yes.
4	CHAIRMAN FAY: Okay. Great. With that,
5	Commissioners, any other comments or discussion?
6	With that, I will entertain a motion on Item
7	5. Thank you, Mr. Cicchetti.
8	COMMISSIONER CLARK: Move to approve the
9	petition, Mr. Chairman.
10	COMMISSIONER GRAHAM: Second.
11	CHAIRMAN FAY: I have a motion and a second.
12	All that support, say aye.
13	(Chorus of ayes.)
14	CHAIRMAN FAY: None opposed. With that, Item
15	5 passes.
16	Commissioners, is there any other business?
17	This agenda conference is adjourned. Thank you so
18	much.
