Re: Existing Rule Review, Public Service Commission, Rules 25-25-003, 00.61., 015,. 023, and .025.

Dear Ms. Jackson:

This letter responds to your February 4, 2022, letter concerning Rules 25-25-003, 00.61., 015, .023, and .025., F.A.C. We have been in the process of reviewing all of our purchasing rules, i.e., the entire Chapter 25-25, F.A.C., and in response to your letter, offer the following comments.

25-25.003(21):	The quoted language in this subsection requires updates to track the requirement in section $120.57(3)(a)$ , F.S.
<u>Response:</u>	Commission staff has reviewed this rule and determined that this rule may be amended or, alternatively, repealed as unnecessary. Staff anticipates that rulemaking will be initiated in the next few months to amend or repeal this rule.
25-25.0061(2):	The reference to rule 60A-1.012, F.A.C., requires updating as that rule was repealed.
<u>Response:</u>	Commission staff has reviewed this rule and determined that this rule may be amended or, alternatively, repealed as unnecessary. Staff anticipates that rulemaking will be initiated in the next few months to amend or repeal this rule.



- **25-25.015:** This rule requires the use of a form, but does not set forth the name or incorporative information for that form. Updates are necessary to bring this language in line with requirements found in section 120.54(1)(i), F.S., and rule 1-1.013(2), F.A.C.
  - **Response:** Commission staff has reviewed this rule and determined that this rule may be amended or, alternatively, repealed as unnecessary. Staff anticipates that rulemaking will be initiated in the next few months to amend or repeal this rule.
- **25-25.023(2):** It is unclear from this subsection what criteria the Commission considers in determining whether to reject an application. *See* §120.52(8)(d), Fla. Stat. (2021). Please review and revise.
  - **Response:** Commission staff has reviewed this rule and determined that this rule may be amended or, alternatively, repealed as unnecessary. Staff anticipates that rulemaking will be initiated in the next few months to amend or repeal this rule.
- **25-25.023(3):** This subsection sets forth that reasonable grounds for removal from vendor files and mailing lists, "may include but shall not be limited to," certain enumerated grounds. The use of the quote phrase implies that there are additional grounds that could be enforced that are not enumerated. *See* §120.52(8)(d), Fla. Stat. (2021). Please review and advise.
  - **Response:** Commission staff has reviewed this rule and determined that this rule may be amended or, alternatively, repealed as unnecessary. Staff anticipates that rulemaking will be initiated in the next few months to amend or repeal this rule.
- **25-25.025(1):** This reference should be to "minority business enterprises" as defined in section 288.703. F.S.
  - **Response:** Commission staff has reviewed this rule and determined that this rule may be amended or, alternatively, repealed as unnecessary. Staff anticipates that rulemaking will be initiated in the next few months to amend or repeal this rule.
