Orlando Utilities Commission ("OUC") is submitting with this letter a revision to its Electric Line Extension Policy, along with supporting material, to the Florida Public Service Commission for your review. On July 12, 2022, OUC staff will be presenting the proposed revision to the OUC Board for adoption. The changes will become effective July 13, 2022.

OUC is also submitting with this letter a corresponding revision for the City of St. Cloud ("St. Cloud") tariff that will become effective the same time as OUC's revision, July 13, 2022.

Electric Line Extension Policy

OUC Tariff Sheet No. 3.020 St. Cloud Tariff Sheet No. 5.02

Significant worldwide demand for commodities used in the manufacturing of transformers and other materials has greatly impacted the industry. As a result, OUC is experiencing longer procurement times for acquiring electric distribution equipment, including, but not limited to, primary wire, transformers, switchgear, and distribution poles. In some cases, delivery times are months longer than what was considered normal in the past. Currently, delivery times for primary wire, transformers and switchgear have increased up to 160 weeks, and the situation is expected to continue throughout this year.

To mitigate the impact of these increased equipment costs on OUC's general body of rate payers a \$16 per kVA contribution in aid of construction ("CIAC") will be required from all parties requesting transformers for new construction effective July 13, 2022. This \$16 per kVA CIAC requirement is equal

to the weighted average overhead and pad mount transformer cost increase OUC has experienced since the beginning of the COVID-19 pandemic. The new CIAC requirement has been communicated to residential and commercial builders, and will increase the cost of new, single-family residential construction by approximately \$135 per home.
