According to the PSC's Statement of Agency Organization and Operations I need to submit a request to be added to the Docket File - mailing address file for this utility company.

I am making this official request and feel that I am entitled to be on the mailing list because I have written a formal objection to the way in which this utility is filing for a name change and has failed to report a transfer a majority of organizational control or to provide the required Parent Affiliate Organizational Chart with any of their annual financial reports.

I am a customer of this utility and for the last three years they communicated with me and over 800 other customers using a utility name that divested itself of any ownership interest in this public utility. I called them out on it in July 2022 and I believe that is what prompted them to start to put their filings with the Florida Department of State and the PSC in order.

I think this entitles me to be notified of how this request and my objection proceeds.

Please let me know when my name and contact information has been added to the file.

I would also like to be notified in the future any time this public utility submits any requests for rate increases or any other administrative change. I am a customer and I feel that they do not accurately report their financial information to the PSC and I want to watch them each year when they submit their requests so that I can submit timely objections.
