2. Referring to paragraph 12 of the petition, please explain the factors that led to the \$563,794 under-recovery (including interest) in 2021.


A. The primary factor that led to the \$563,794 under-recovery in 2021 is lower than projected sales of natural gas. In 2021, \$5,206,120 of CI/BSR Revenue net of Regulatory Assessment Fee was collected, as shown on line 1 on page 2 of Exhibit A of the petition filed with the Commission on September 1, 2022, in Docket No. 20220152-GU ("2023 Projection Filing"). This was \$295,420 lower than the estimated amount of \$5,501,540 of CI/BSR Revenue for 2021 shown on line 1, page 2 of Exhibit B in the petition filed on September 1, 2021, in Docket No. 20210148-GU ("2022 Projection Filing"). This reduced revenue was the main driver for the variance between the \$344,870 estimated under-recovery for 2021 shown in the 2022 Projection Filing, and the True-up of \$563,794 shown in the 2023 Projection Filing.

- 3. Please discuss the progress of Cast Iron/Bare Steel Pipe Replacement Rider projects and Problematic Plastic Pipe replacement projects in 2021, 2022, and those planned for 2023.
- **A.** Peoples Gas System ("Peoples Gas or the Company") has made significant progress in its cast iron/bare steel ("CI/BS") and problematic plastic pipe (PPP) replacement projects under the Commission approved CI/BS Replacement Rider ("Rider CI/BSR").

As discussed in more detail below, Peoples Gas experienced delays in CI/BS replacement that will prevent the Company from completing the CI/BS projects within the projected 10-year time period (by the end of 2022) under Rider CI/BS. Peoples Gas expects to have approximately 3.4 miles remaining (more detail below) as we enter 2023. Peoples Gas continues to work towards replacing all PPP in its system by 2028, in accordance with Rider CI/BSR.

By including both the CI/BS and PPP infrastructure replacement projects in the proposed recovery factor for 2023, Peoples Gas intends the remaining 3.4 miles of CI/BS replacement be recovered through the Company's Rider CI/BSR beyond the projected ten-year period for the CI/BSR portion. To the extent that the Commission disagrees with this process, Peoples Gas would submit a request to extend the CI/BS portion of Rider CI/BSR.

Cast Iron/Bare Steel Pipe Replacement Rider Projects and Problematic Plastic Pipe Replacement Projects in 2021

In 2021, Peoples Gas continued to focus on CI/BS replacement projects in Miami, Tampa, St. Pete, and Orlando. At the end of 2021, Peoples Gas replaced approximately 14 miles of CI/BS.

In 2021, Peoples Gas continued replacement of PPP in Jacksonville, Eustis, and Ocala. Peoples Gas also began replacements in Daytona and Avon Park. At the end of 2021, Peoples Gas replaced approximately 38 miles of PPP.

Cast Iron/Bare Steel Pipe Replacement Rider Projects and Problematic Plastic Pipe Replacement Projects in 2022

In 2022, Peoples Gas continued to focus on CI/BS replacement projects in Miami, Tampa, St. Pete, Orlando, and Jacksonville to meet the program's approved 10-year period. However, Peoples Gas will have approximately 3.4 miles of CI/BS replacement remaining as we enter 2023. The COVID-19 Pandemic environment greatly contributed to replacement efforts going beyond the 10-year period. Factors include construction contractor labor shortages, consulting firm (e.g., engineering) availability, supply chain challenges, and extensive permitting challenges. Additionally, in the City of Miami, construction moratoriums currently in place will delay work in replacing 0.4 miles of pipe in this area until 2027.

In 2022, Peoples Gas continued replacement of PPP in Jacksonville, Orlando, Eustis, Daytona, Ocala, and Avon Park.

Cast Iron/Bare Steel Pipe Replacement Rider Projects and Problematic Plastic Pipe Replacement Projects in 2023

In 2023, Peoples Gas will continue to focus on CI/BS replacement projects in Miami, Orlando, and Jacksonville. Although contingent on work completed in the remainder of 2022, Peoples Gas estimates the remaining replacement mileage for these areas at the beginning of 2023 to be as follows:

 Miami: 0.2 miles CI / 2.3 miles BS (Note: 0.4 miles of bare steel replacement is delayed due to a construction moratorium until 2027)

Orlando: 0.2 miles BSJacksonville: 0.7 miles BS

In 2023, Peoples Gas will continue replacement of PPP in Jacksonville, Orlando, Eustis, Lakeland, Daytona, Ocala, and Jupiter.
