NOTICE is hereby given that the staff of the Florida Public Service Commission (Commission) will conduct a customer meeting to discuss Anglers Cove West, Ltd.'s (Anglers Cove or Utility) application for a staff-assisted rate case (SARC) in Polk County. The originally scheduled customer meeting has been rescheduled due to Hurricane Ian, and will be held virtually on the following date and time:

Thursday, November 3, 2022, at 10:00 a.m.

PURPOSE AND PROCEDURE

The purpose of this meeting is to give customers and other interested persons an opportunity to offer comments to Commission staff regarding the quality of service the Utility provides and on the preliminary rates included in this notice. Customers and other interested persons may be asked follow-up questions. These comments will be taken into consideration by the Commission in its decision regarding the proposed rate increase.

This customer meeting will be conducted virtually. The Commission shall act as the host of the customer meeting and will use a combination of technologies to ensure full participation. The Commission will employ GoToMeeting as an audio and video platform for the meeting, and will provide for simultaneous, audio-only participation by telephone. Persons wishing to provide comments will present their comments over the telephone.

One or more of the Commissioners may attend and participate in this meeting. The meeting will begin as scheduled and will continue until all the customers have been heard.

If a named storm or other disaster requires cancellation of the meeting, Commission staff will attempt to give timely direct notice to the parties. Notice of the cancellation of the meeting will also be provided on the Commission's website under the Hot Topics link found on the home page. BACKGROUND

Anglers Cove is a Class C water and wastewater utility that began operations in 1986. The Utility provides water service to approximately 344 residential and 6 general service customers, and provides wastewater service to approximately 344 residential and 2 general service customers in the Anglers Cove and Anglers Cove West Mobile Home Parks in Polk County. Anglers Cove purchases water from the City of Lakeland as the Utility does not have a water treatment plant. Anglers Cove was granted Certificate Nos. 610-W and 526-S by the Commission in 1999.¹ The Utility's rates were last established during a staff-assisted rate case (SARC) in 2008.²

On February 11, 2022, Anglers Cove filed an application for a SARC. Pursuant to Section 367.0814(2), Florida Statutes (F.S.), the official filing date of the SARC has been determined to be April 11, 2022. The 12-month period ending December 31, 2021, was selected as the test year for the instant case.
