2	CHAIRMAN FAY: Next we will move into Item No.
3	7 to be presented this morning by Ms. Thompson.
4	Ms. Thompson, you are recognized when you are
5	ready.
6	MS. THOMPSON: Good morning, Commissioners.
7	Takira Thompson with Commission staff.
8	Item 7 is staff's recommendation regarding the
9	application for a staff-assisted rate case by
10	Anglers Cove West, Ltd.
11	Anglers Cove is a Class C water and wastewater
12	utility in Polk County with approximately 410 water
13	customers and 408 wastewater customers.
14	Based on our analysis, staff is recommending a
15	40.32 percent revenue requirement increase, or
16	\$30,253 annually for water, and a 29.5 cents
17	percent revenue requirement increase, or \$21,510
18	annually for wastewater.
19	A customer meeting was held on November 3rd,
20	2022, and one customer provided comments.
21	Additionally, two customers filed comments in the
22	docket regarding the rate increase and the size of
23	the percolation pond at this wastewater treatment
24	plant.
25	Staff and the utility are available for any

1	questions.
2	CHAIRMAN FAY: Great. Thank you, Ms.
3	Thompson.
4	Commissioners, at this time we will take any
5	comments or a motion.
6	Commissioner Graham, you are recognized.
7	COMMISSIONER GRAHAM: Thank you, Mr. Chair.
8	I didn't think it was necessary to pull this
9	item, but I want to take two seconds to comment to
10	staff.
11	You know, in the past, if a utility purchased
12	the water, we just kind of gave them a pass on the
13	primary and secondary water quality standards, but
14	I think we need to hold everybody accountable to
15	that. And staff actually reached out to the City
16	of Lakelands, who they are purchasing the water
17	from, and still checked to make sure the primary
18	and secondary water is the standard it's supposed
19	to be. So I do appreciate us going that extra
20	mile, and I think we should always be able to hold
21	those people accountable for it.
22	Thank you.
23	CHAIRMAN FAY: Great. Thank you, Commissioner
24	Graham. I know you are on top of these items, so I
25	appreciate the input.

1	With that, Commissioners, Commissioner Graham
2	force comments, we will entertain a motion on Item
3	No. 8 at this time.
