4	MS. GUFFEY: Item 4 is the joint petition from	
5	the City of Milton and the Okaloosa Gas District	
6	requesting approval of a new territorial agreement	
7	in Santa Rosa County. Specifically, the joint	
8	petitioners seek to clearly define the mutually	
9	agreed upon service boundaries in Santa Rosa	
10	County. There are no customer or facility	
11	transfers contemplated in this 25-year agreement.	
12	At the end of the 25 year term, the agreement will	
13	renew every five years.	
14	The agreement will enable the two utilities to	
15	provide retail natural gas service to their current	
16	and future customers in an economical manner, and	
17	avoid potential duplication of facilities and	
18	services.	
19	Staff recommends approval of this joint	
20	petition, and also notes that an oral modification	
21	to this recommendation has been provided to the	
22	Commission offices, and a copy has been placed in	
23	the docket file.
