1 P R O C E E D I N G S

2 CHAIRMAN FAY: And we have one more with Mr.  
3 Hampson, correct?

4 MR. HAMPSON: That's correct.

5 CHAIRMAN FAY: All right. Go ahead.

6 MR. HAMPSON: Item 10 is Florida City Gas's  
7 petition requesting approval of the Safety Access  
8 and Facility Enhancement, or SAFE Program, true-up  
9 and cost recovery factors for January through  
10 December 2023. The fixed monthly surcharge  
11 recovers costs associated with the expedited  
12 relocation of certain existing gas mains and  
13 associated facilities from rear-lot easements to  
14 the street front.

15 The proposed fixed surcharge is 44 cents per  
16 month for customers using less than 6000 therms per  
17 year and 98 cents per month for customers using  
18 more than 6000 therms per year. Given Florida City  
19 Gas's currently ongoing rate case in Docket  
20 20220069-GU, any modifications to the SAFE program  
21 approved by the Commission should be reflected in  
22 the utility's next annual SAFE filing. Staff  
23 recommends approval of the petition.

24 CHAIRMAN FAY: Okay. Great. Thank you, Mr.  
25 Hampson.

1           Commissioners, you have a description of Item  
2           No. 10. We will entertain a motion on that item.

3           COMMISSIONER CLARK: Move to approve the item,  
4           Mr. Chairman.

5           COMMISSIONER GRAHAM: Second.

6           CHAIRMAN FAY: We have a motion for approval on  
7           staff's recommendation for all issues, motion and a  
8           second. All that approve say, aye.
