13	transportation service, allowing the delivery of		
14	natural gas in the Nassau County for a 19-month		
15	term commencing on November 1st, 2022. Pursuant to		
16	the proposed contract, the receipt points, delivery		
17	points and points of delivery would remain the same		
18	as in the 2021 agreement. Staff recommends		
19	approval of the proposed contract.
