Pursuant to Section 366.093 of the Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Florida Power & Light (FPL or Company) requests an extension of confidential classification of certain information filed in the above-referenced docket, dated June 15, 2021.

The Company is claiming confidentiality of its information under Section 366.093(3)(e), F.S. Per the Statute, propriety of confidential business information includes, but is not limited to: Subsection (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of information."

More specifically, some information pertains to projected capital costs and software that is proprietary to a third-party vendor who provides it to FPL as part of a subscription service.

Staff has reviewed the Company's extension of confidentiality request, and in staff's opinion, the request meets the criteria for an extension of confidentiality contained in Section 366.093(3)(e), F.S.
