Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Peoples Gas System, Inc. (PGS or Company) requests confidential classification for certain highlighted information contained within PGS's Supplemental Response to Data Request No. 7 in Staff's First Data Request (Nos. 1-16), as appears in Document No. 02890-2023, filed on April 26, 2023.

The Company is claiming confidentiality for certain information contained within PGS's Supplemental Response to Data Request No. 7 in Staff's First Data Request (Nos. 1-16) under Section 366.093(3), F.S. Per the Statute, propriety of confidential business information includes, but is not limited to: Subsections (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." The information provided in the aforementioned response for which confidential treatment is being sought can be described as information revealing commercially sensitive contractual details located within 1) Appendix E to the First Amendment to the Renewable Natural Gas Service Agreement and 2) the Second Amendment to the Purchase and Sales Agreement.

Staff has reviewed the information within Appendix E to the First Amendment to the Renewable Natural Gas Service Agreement and the Second Amendment to the Purchase and Sales Agreement, as well as the Company's confidentiality request. In staff's opinion, the information that is the subject of the confidentiality request does meet the criteria for confidentiality contained in Section 366.093(3)(d) and (e), F.S. Therefore, staff recommends that the request for confidentiality of the afore-mentioned, highlighted information included in Document No. 02890-2023, be approved.
