Pursuant to Section 366.093 of the Florida Statutes (F.S), and Rule 25-22.006, Florida Administrative Code, Peoples Gas System, Inc. (PGS or Company) requests confidential classification of highlighted information being provided on April 14, 2023, in response to Staff's Third Data Request, Nos. 1 - 4 issued in the above dockets, which relate to a series of agreements between PGS and Brightmark Sobek RNG, LLC.

PGS is claiming confidentiality of its response to Staff's Third Data Request, Nos. 1 - 4, under Section 366.093(3)(d)-(e), F.S. Per the statute, propriety of confidential business information includes, but is not limited to: Subsection (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and Subsection (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." The Company maintains that the information provided in the aforementioned response for which confidential treatment is being requested contains competitive business information.

Staff has reviewed the information provided in PGS's response to Staff's Third Data Request, Nos. 1 - 4, as well as the Company's confidentiality request. In staff's opinion, the information that is the subject of the confidentiality request does meet the criteria for confidentiality contained in Section 366.093 F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 02686-2023 be approved.
