PEOPLES GAS SYSTEM INC.'S AMENDED NOTICE OF INTENT TO REQUEST FOR CONFIDENTIAL CLASSIFICATION

Peoples Gas System, Inc. ("Peoples" or "the company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006(3)(a), Florida Administrative Code, hereby files this Amended Notice of Intent to Request Confidential Classification for portions of the direct testimony and exhibits of the Office of Public Counsel's witness Lane Kollen and in support thereof states:

- 1. On June 22, 2023, the Office of Public Counsel filed the direct testimony and exhibits of witnesses Lane Kollen and David Garrett. *See* DN 03750-2023; DN 03752-2023. The Office of Public Counsel designated these filings as confidential in order to give Peoples an opportunity to review them and determine if any portions thereof constitute "proprietary confidential business information" entitled to protection under Section 366.093, Florida Statutes and Rule 25-22.006, Florida Administrative Code.
- 2. That same day, Peoples filed a Notice of Intent to Request Confidential Classification for the Office of Public Counsel's direct testimony and exhibits. *See* DN 03740-2023.

3. Peoples has since reviewed the Office of Public Counsel's filings and determined that the Mr. Garrett's testimony and exhibits *do not* contain proprietary confidential business information. As a result, Peoples withdraws its initial Notice of Intent and Mr. Garrett's testimony

4. Peoples also concluded, however, that Mr. Kollen's testimony and exhibits *do include* proprietary confidential business information. Peoples accordingly submits this Amended

Notice of Intent to Request Confidential Classification and affirms that portions of Mr. Kollen's

testimony and exhibits do contain proprietary confidential business information.

may be treated by the parties and the Commission as non-confidential.

5. Accordingly, and pursuant to Rule 25-22.006(3)(a) and (d), Florida Administrative

Code, Peoples respectfully requests confidential handling of Mr. Kollen's testimony and exhibits

while the company reviews that material, identifies which components constitute proprietary

confidential business information, and prepares a Request a Confidential Classification. Peoples

will file such a Request specifying the information entitled to confidential treatment within twenty-

one days of June 22, 2023 (the date of its initial notice of intent to request confidential

classification) in accordance with Rule 25-22.006(3)(a)1, Florida Administrative Code.
