Pursuant to Section 366.093 of the Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), People's Gas System, Inc. (PGSI or Company) requests confidential classification of highlighted information contained in the response to Staff's First Request for Production of Documents, Numbers 1 and 2. The Request for this data was filed on July 27, 2023, and is Document No. 04329-2023. The material that is subject of this request is found in Document No. 04331-2023.

The Company is claiming confidentiality for certain information in the response under Section 366.093(3), F.S. Per the referenced Statute, propriety of confidential business information includes, but is not limited to: (a) trade secrets; (b) internal auditing controls and reports of internal auditors; (c) security measures, systems, or procedures; (d) information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms; (e) information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information; and (f) employee personnel information unrelated to compensation, duties, qualifications, or responsibilities. The Company asserts that the information subject of this request falls within one or more of these statutory categories and, thus, constitutes proprietary confidential business information entitled to protection under Section 366.093, F.S., and Rule 25-22.006, F.A.C. According to the Company, the information is intended to be and is treated by it as private information that has not not been publicly disclosed. The information provided in the aforementioned exhibit for which confidential treatment is being sought can be described as competitively sensitive information. A justification summary is shown below:

(1) The highlighted text thus constitutes "information concerning bids ... the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms" and is protected under Section 366.093(3)(d), Florida Statutes.

(2) The highlighted information relates to competitive interests, the disclosure of which would impair the competitive business of the provider of the information. This information is protected by Section 366.093(3)(e), Florida Statutes.

(3) The highlighted information pertains to security measures, systems, or procedures. This information is protected under Section 366.093(3)(c).

Staff has reviewed the information contained in the responses to Staff's First Request For Production of Documents, Items 1 and 2, as well as the Company's confidentiality request. In staff's opinion, the information that is the subject of the confidentiality request does meet the criteria for confidentiality contained in Section 366.093(3), F.S. Therefore, staff recommends that the request for confidentiality of the afore-mentioned information included in Document No. 04331-2023 be approved.
