Please explain how the Utility developed the charges for the 6-inch, 8-inch, and 10-inch meter sizes.
- 2. Please refer to Schedule E-14. Please identify all general service customers, including the irrigation customers, by name.
- 3. Please refer to the Utility's approved tariffs for water and wastewater service availability charges. Please indicate how many customers are currently paying guaranteed revenue charges.
- 4. Please refer to the revised Schedule F-1 submitted September 20, 2023.
 - a. Please explain how the Utility sold and used more water than it pumped in June, July, September, October, and December of 2022, and February and April of 2023.
 - b. What were the "Other Uses" listed on this Schedule?
- 5. Please refer to Schedule F-3. Please explain why Royal chose May 18, 2023, with 461,000 gallons pumped and May 28, 2023, with 483,000 gallons pumped instead of May 13, 2023, with 504,000 gallons pumped and May 14, 2023 with 503,000 gallons pumped, for the five-day maximum year calculation.

- 6. Please refer to Schedule F-5. Please explain how Royal determined the growth factor.
- 7. Please refer to the Additional Engineering Information, Chemical Analysis. Please provide the most recent chemical analysis for the disinfection byproducts of TTHM and HAA5.
- 8. Please refer to the Additional Engineering Information, Sanitary Survey.
 - a. The Survey shows three storage tanks, one ground, one hydropneumatic, and a Clearwell tank. Is the Clearwell tank considered an above ground, ground, or hydropneumatic tank?
 - b. Did the FDEP accept the Utility's repairs to cure the deficiencies found by the Survey? If so, please provide the FDEP response letter.
