By this letter, Commission staff requests that Royal Waterworks, Inc. (Royal or Utility) provide responses to the following questions.

1. Please provide the following information with regard to the identified accounts.
 - a. **603/703 - Salaries & Wages – Officer:** Please provide an explanation for the officer's salary calculation of \$2,500 monthly for water and \$2,333 monthly for wastewater.
 - b. **675 - Miscellaneous Expense:** Please explain how often lime removal is performed on ponds.
 - c. **371 - Pumping Equipment:** Please provide the plant additions and retirements for the test year.
 - d. **371 – Pumping Equipment:** Please provide descriptions and costs for requested pro forma adjustments.
2. Please refer to revised Schedule B-1. For water net operating income, in column 6, the Utility's proposed revenues do not match the proposed revenues shown on revised schedule E-2, column 13. Please explain why the proposed revenues differ by \$522.
3. Please refer to revised Schedule B-2. For wastewater net operating income, in column 6, the Utility's proposed revenues do not match the proposed revenues shown on revised schedule E-2 for wastewater, column 11. Please explain why the proposed revenues differ by \$1,798.
