## Section 63.71 Application of ACN Communication Services, LLC

ACN Communication Services, LLC ("ACN" or "Applicant"), hereby seeks authorization pursuant to Section 214 (a) of the Communication Act of 1934, as amended, and 47 C.F.R. §63.71, to discontinue the provision of interconnected VoIP service to its commercial customers in all U.S. states and the District of Columbia, with the exception of Alaska and Hawaii where the service has never been offered. ## 3. Date of Planned Service Discontinuance, Reduction or Impairment:

ACN proposes to discontinue the services that are the subject of this Application on or about December 31, 2023, pending required federal regulatory approval of the discontinuance.

## 4. Points of Geographic Areas of Service Affected:

ACN proposes to discontinue the services described herein to all customers in all U.S. states and the District of Columbia, with the exception of Alaska and Hawaii where these services have never been offered. The affected services provided to existing customers will be discontinued and services will no longer be offered to new commercial customers in those locations following the proposed discontinuance.

## 5. Brief Description of Types of Service Affected and Reason for Discontinuance:

The discontinuance is for interconnected VoIP services provided to commercial customers, marketed as ACN DigitalTalk and DigitalTalk *Express*. These services provide customers with local, intrastate and interstate long-distance voice calling. There are approximately 748 total customers impacted by the discontinuance of these services. The services are being discontinued due to changes in the Applicant's business strategy.

As described below, ACN is providing all affected customers with ample notice of the discontinuance and has provided customers with a toll-free customer service number that they may call for assistance. Further, ACN has negotiated an agreement with Intermedia.net, Inc. to provide affected customers with comparable alternative services. Customers have been informed of this option in the attached notice. Customers impacted by the discontinuance are also free to select other alternative service providers.

6. Brief Description of Dates and Methods of Notice to All Affected Customers:

The Applicant has provided written customer notice of the planned discontinuance in accordance with the requirements of section 63.71 (a) of the Commission's Rules. Notice was provided via email to affected customers in four batches sent on October 5, October 9, October 23 and October 30, 2023. For any email notices that were returned as non-deliverable, the Applicant sent the notice to the customer via U.S. mail on November 3, 2023. Thus, notices were sent to all affected customers on or before November 3, 2023. The notice is attached as Exhibit A.

A copy of this Application is being sent to the state public service or utility commissions and

governors' offices in the affected states, as well as to the Secretary of Defense, as required under Section 63.71, concurrent with this filing. A service list is provided in Exhibit B.


