2	CHAIRMAN FAY: All right. Commissioners, next
3	we will move to Item No. 4. Ms. Eichler will
4	present the item this morning.
5	You are recognized.
6	MS. EICHLER: Good morning, Commissioners.
7	Shelby Eichler with IDM.
8	Item No. 4 is staff's recommendation for the
9	storm protection plan cost recovery clause
10	establishing cost recovery factors for 2024.
11	The Commission conducted an administrative
12	hearing for this docket on September 12th, 2023.
13	The parties waived cross-examination and stipulated
14	to the admission of all prefiled testimony of the
15	witnesses. TECO, FPUC, DEF, FPL, OPC and PCS
16	submitted post-hearing briefs. FIPUG and Nucor
17	joined in OPC's brief.
18	As reflected in staff's recommendation,
19	parties have agreed to Type 2 stipulations for
20	Issues 5 through 6 and 8 through 10. Parties have
21	also agreed to partial Type 2 stipulations for
22	Issues 1 through 4 and 7, for the factors only,
23	subject to a legal argument forwarded by OPC.
24	Staff recommends that the Commission reject
25	OPC's legal argument which allows Commission

1	consideration of Type 2 stipulations on all issues.
2	Staff believes the record supports these proposed
3	stipulations and recommends that they be approved
4	by the Commission.
5	Staff would also like to note that there has
6	been an oral modification approved for this
7	recommendation.
8	Staff is prepared to answer questions. Thank
9	you.
10	CHAIRMAN FAY: Okay. Thank you, Ms. Eichler.
11	Commissioners, any questions or comments on
12	this item?
13	We will take up a motion with that oral
14	modification included.
15	COMMISSIONER CLARK: Move to approve staff
16	recommendation along with the oral modification,
17	Mr. Chairman.
