Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, (F.A.C.), Florida Power & Light Company (FPL) filed a first request for extension of confidential classification of certain information provided in response to the Office of Public Counsel's (OPC) third request for production of documents (POD), No. 7. FPL requests confidentiality under Section 366.093(3)(e), F.S., citing "the confidential business information includes information related to competitive interests. The disclosure of this information would impair the competitive business of FPL."

The information for which FPL seeks confidentiality can be described as a credit and equity analysis provided by third party rating agencies, for which the information is not available to the general public. The information also contains cost of debt assumptions by FPL.
