Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Tampa Electric Company (TECO or Company) requests confidential classification of certain information contained in the response to staff's first data request, Nos. 2, 5, and 6. TECO requests confidentiality of various responses under Section 366.093(3), subpart (d), F.S., which states: [i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and subpart (e), F.S., which states: "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information."

TECO requests confidentiality pursuant to 366.093(3)(d) and (e), F.S. for all three responses. The information provided in response Nos. 2 and 5 that can be described as system economic analyses including contract payments, while the information provided in response No. 6 can be described as contract payment estimates and termination payment values. Therefore, staff recommends that this information meets the criteria for confidential classification pursuant to Section 366.093(3) (d) and (e), F.S.
