2	COMMISSIONER PASSIDOMO: Okay. Good
3	afternoon, everyone. Today is Tuesday, March 19th,
4	2024. It is 1:30 p.m., and I will now call this
5	Prehearing Conference to order.
6	Just as a preliminary thing that I want to
7	say. This is my first time using GoToMeeting, so
8	there might be a time when I am going to ask
9	whether the parties are in agreement to something,
10	and instead, I am just going to go through I
11	might just kind of go down the list to get verbal
12	confirmation from everybody. And that's not to,
13	like, be repetitive or anything. I just want to
14	make sure, since we do have the time, that I am not
15	skipping anybody.
16	So with that being said, staff, would you
17	please read the notice?
18	MS. BROWNLESS: By notice issued on March
19	12th, 2024, this time and place has been set for a
20	Prehearing Conference in Docket No. 20240001-EI.
21	The purpose of the prehearing is to determine
22	the prudence and potential replacement power cost
23	recovery associated with Florida Power & Light
24	Company's actions or failure to act resulting in
25	unplanned nuclear power plant outages during the

1 2020 through 2022 time period. 2. COMMISSIONER PASSIDOMO: Thank you, Ms. 3 Brownless. 4 Let's move to appearances. 5 Florida Power & Light. Thank you, Commissioner. 6 MS. MONCADA: 7 Maria Moncada for Florida Power & Light 8 Company. I would like to also enter an appearance 9 for David Lee. 10 And thank you for allowing me the opportunity 11 to appear via GoToMeeting. 12 COMMISSIONER PASSIDOMO: Thanks, Ms. Moncada. 13 Office of Public Counsel. 14 MR. REHWINKEL: Good morning -- good afternoon, Commissioner. 15 16 Charles Rehwinkel, Patty -- on behalf of the 17 Office of Public Counsel. I would also like to enter an appearance for Patty Christensen and Walt 18 19 Trierweiler, the Public Counsel. 20 COMMISSIONER PASSIDOMO: Thank you. 21 FIPUG. 22 MR. MOYLE: Thank you. Jon Moyle on behalf of the Florida Industrial 23 24 Power Users Group, FIPUG. And I would like to 25 enter an appearance for Karen Putnal as well.

1	COMMISSIONER PASSIDOMO: Thank you, Mr. Moyle.
2	FRS FRF.
3	MR. WRIGHT: Thank you, Commissioner.
4	Robert Scheffel Wright on behalf of the
5	Florida Retail Federation. I would like to also
6	enter an appearance for my law partner, John T.
7	LaVia, III.
8	Thank you.
9	CHAIRMAN LA ROSA: Thank you, Mr. Wright.
10	Staff.
11	MS. BROWNLESS: Yes, ma'am.
12	Suzanne Brownless and Ryan Sandy on behalf of
13	Commission staff.
14	MS. HELTON: And Mary Anne Helton is here as
15	your Advisor. I would also like to enter an
16	appearance for your General Counsel, Keith Hetrick.
17	COMMISSIONER PASSIDOMO: Thank you, Mary Anne.
18	Okay. Staff, are there any preliminary
19	matters we need to address before we get to the
20	Draft Prehearing Order?
21	MS. BROWNLESS: Yes, ma'am.
22	This proceeding comes to the Commission in an
23	unusual procedural posture. The issues to be
24	determined in this proceeding were deferred from
25	the 2023 fuel clause docket, and are associated

1	with nuclear power plant outages that occurred at
2	FPL, St. Lucie Units 1 and 2, and Turkey Point
3	Units 3 and 4 between 2020 and 2022.
4	At this time, there are only four parties to
5	the fuel clause docket that have standing to
6	participate in this proceeding, FPL, the Office of
7	Public Counsel, Florida Industrial Power Users
8	Group and Florida Retail Federation.
9	The other parties to the docket that are
10	without standing to participate in this proceeding
11	are the other investor-owned electric utilities,
12	TECO, DEF and FPUC, Nucor and PSC Phosphate. TECO,

in this proceeding.

OPC and FPL have stipulated to the two issues in this case. FRF and FIPUG have stated that they take no position on the issues raised in this proceeding.

DEF Nucor and PCS Phosphate have orally asked and

been granted leave to be excused from participating

FPL filed an unopposed motion to stay filing its rebuttal testimony on March 8th, which was granted by Order No. PSC-2024-0062-PCO-EI, issued on March 11th.

If the stipulations for the two issues are approved at the final hearing, the testimony and

1	exhibits will be moved into the record without
2	objection and the case will be closed.
3	If the stipulations for the two issues are not
4	approved at the final hearing, the case will be
5	continued until a later date, and a new trial
6	schedule will be set with new filing dates for
7	rebuttal testimony, revised prehearing statements,
8	et cetera.
9	No testimony or exhibits will be admitted into
10	the record if the stipulations are not approved.
11	COMMISSIONER PASSIDOMO: Okay. Thank you, Ms.
12	Brownless.
13	All right. Now we are going to go through the
14	draft prehearing order. I will identify the
15	sections and want the parties to let me know if
16	there are any corrections or changes or to be made.
17	Some of the sections I will probably go through
18	fairly quickly, so please just speak up if there is
19	a change or correction you would like to make.
20	So we will start Section I, Case
21	Backgrounding.
22	Section II, Conduct of Proceedings.
23	Section III, Jurisdiction.
24	Section IV, Procedure for Handling
25	Confidential Information.

1	Section V, Prefiled Testimony and Exhibits,
2	Witnesses.
3	MS. BROWNLESS: Yes, ma'am.
4	And again, all parties have agreed that all
5	witnesses can be excused from the final hearing on
6	March 26th, as have all Commissioners. That being
7	the case, there will be no witness summaries given
8	at the hearing.
9	COMMISSIONER PASSIDOMO: Thank you.
10	Section VI now, Order of Witnesses.
11	MS. BROWNLESS: And again, all Commissioners
12	and parties have agreed that all witnesses can be
13	excused. Therefore, the order of witnesses will be
14	addressed only if stipulations are not approved by
15	the Commission.
16	COMMISSIONER PASSIDOMO: Section VII, Basic
17	Positions. So do any of the parties have any
18	changes to their basic positions?
19	MR. REHWINKEL: No.
20	MR. WRIGHT: No.
21	MS. MONCADA: FPL has no changes.
22	COMMISSIONER POLMANN: Thank you, Ms. Moncada.
23	MR. MOYLE: No changes.
24	COMMISSIONER PASSIDOMO: Okay. Thank you.
25	All right. So then with no changes, we will

1	move we will move on to the issues, and I will
2	kind of go through those in numerical order.
3	So yeah, go ahead, staff.
4	MS. BROWNLESS: In this case, the issues and
5	positions reflect the proposed stipulation for both
6	Issues 1 and 2 and will be discussed in more detail
7	in Section X.
8	COMMISSIONER PASSIDOMO: All right. Let's
9	move to the comprehensive exhibit list.
10	MS. BROWNLESS: Staff has prepared a
11	comprehensive exhibit list which lists all prefiled
12	exhibits and those exhibits staff wishes to include
13	in the record. The draft list was provided to the
14	parties to see if there were any changes or
15	objection to the CEL. We would ask at this time if
16	there are any changes to the CEL.
17	Per the proposed stipulation, the parties have
18	agreed that the exhibits listed on the CEL will be
19	placed into the record should the proposed
20	stipulation be approved by the Commission. If the
21	Commission does not approve the proposed
22	stipulation, the admission of the CEL exhibits into
23	the record will be taken up when the final hearing
24	is reconvened.
25	So I quess what we need now the now is

1	confirmation that the confidential exhibit list is
2	correct.
3	COMMISSIONER PASSIDOMO: Ms. Moncada?
4	MS. MONCADA: FPL agrees that the list is
5	correct.
6	Thank you.
7	COMMISSIONER PASSIDOMO: Mr. Rehwinkel?
8	MR. REHWINKEL: The Public Counsel agrees.
9	MR. WRIGHT: FRF agrees. Thank you.
10	MR. MOYLE: As does FIPUG.
11	COMMISSIONER PASSIDOMO: Thank you. Thank you
12	all.
13	Okay. Section X, Proposed Stipulations.
14	MS. BROWNLESS: Yes, ma'am.
15	OPC and FPL have stipulated to the two issues
16	in the case, and I will read them now.
17	Issue 1: What adjustment should be made with
18	respect to replacement power costs associated with
19	any unplanned outages that occurred at Turkey Point
20	or St. Lucie during the calendar years 2020, 2021
21	and 2022?
22	And the stipulation is as followed: FPL shall
23	credit customers five million, inclusive of
24	interest, through the fuel clause. The credit
25	shall be included in the calculation of FPL's fuel

1	factors the next time the fuel factors are reset.
2	The prudence of, and replacement power cost
3	calculations associated with, all forced or
4	unplanned outages or down power events at the
5	Turkey Point and St. Lucie nuclear facilities,
6	which occurred during the calendar years 2020
7	through 2022, are hereby fully resolved and shall
8	not be subject to further challenge or litigations
9	in the future.
10	Issue No. 2: Should FPL be subject to a
11	follow-up nuclear operations and management audit
12	covering the 2024 to 2029 time period?
13	Stipulation: Yes, a follow-up audit may be
14	conducted no earlier than 2030.
15	COMMISSIONER PASSIDOMO: All right. Parties,
16	does this correctly reflect the stipulations that
17	have been agreed to? Ms. Moncada?
18	MS. MONCADA: Correctly reflects the
19	stipulations. Yes.
20	COMMISSIONER PASSIDOMO: Thank you.
21	Mr. Rehwinkel?
22	MR. REHWINKEL: Yes, it correctly reflects the
23	stipulation between the Public Counsel and FPL.
24	COMMISSIONER PASSIDOMO: Thank you.
25	Mr. Wright?

1	MR. WRIGHT: It correctly reflects that we
2	take no position on the issue.
3	Thanks.
4	COMMISSIONER PASSIDOMO: Same with Mr. Moyle?
5	MR. MOYLE: And FIPUG takes no position as
6	well.
7	COMMISSIONER PASSIDOMO: Okay. Thank you.
8	Okay. Section we are going to move to
9	Section XI, Pending Motions.
10	MS. BROWNLESS: There are no pending motions
11	at this time.
12	COMMISSIONER PASSIDOMO: Section XII, Pending
13	Confidential Matters.
14	MS. BROWNLESS: There are no pending
15	confidentiality matters at this time.
16	COMMISSIONER PASSIDOMO: Section XIII,
17	Post-Hearing Procedures.
18	MS. BROWNLESS: Post-hearing procedures will
19	be dep will depend upon whether the proposed
20	stipulations are approved by the Commission or are
21	not approved. If approved, all issues you will be
22	resolved and no further action needs to be taken by
23	the parties. If the Commission does not approve
24	the proposed stipulations, the hearing will be
25	continued, and a revised procedural order will be

1	issued.
2	COMMISSIONER PASSIDOMO: Are all parties in
3	agreement to this?
4	Ms. Moncada? I am sorry I have to keep doing
5	this.
6	MS. MONCADA: Thank you for allowing me,
7	again, to appear virtually and having to go through
8	this.
9	FPL agrees.
10	COMMISSIONER PASSIDOMO: Thank you.
11	Mr. Rehwinkel?
12	MR. REHWINKEL: We agree.
13	MR. WRIGHT: The FRF agrees with these
14	procedural notes.
15	Thanks.
16	MR. MOYLE: So does FIPUG.
17	COMMISSIONER PASSIDOMO: Thank you.
18	Section XIV, Rulings.
19	MS. BROWNLESS: The staff recommends that
20	opening statements be limited to five minutes per
21	party.
22	COMMISSIONER PASSIDOMO: Are the parties in
23	agreement to five minutes for opening statements?
24	Ms. Moncada?
25	MS. MONCADA: FPL agrees to five minutes.

1	COMMISSIONER PASSIDOMO: Mr. Rehwinkel?
2	MR. REHWINKEL: We agree.
3	MR. WRIGHT: That's completely fine with the
4	FRF. We hope it doesn't come to that.
5	COMMISSIONER PASSIDOMO: Yeah. Thank you.
6	MR. MOYLE: And I heard earlier there were
7	some people being excused, and I talked with staff,
8	and I think given where things are, FIPUG is going
9	to respectfully also ask to be excused. So given
10	that, we don't have a position on the opening
11	statement.
12	COMMISSIONER PASSIDOMO: Okay. Right. Okay.
13	Thank you.
14	So let's just conclude up with other matters.
15	Any other matters, staff, to address in this
16	prehearing conference?
17	MS. BROWNLESS: Yes, ma'am.
18	Due to the unusual nature of this proceeding,
19	staff would like to review the procedure to be
20	followed at the March 26th hearing with the
21	parties. And I am just going to go down the list.
22	Call the hearing to order.
23	Read the notice.
24	Take appearances.
25	Preliminary matters, if any.

Do we have any other matters --6 7 MS. MONCADA: No changes to the procedure from 8 FPL. 9 COMMISSIONER PASSIDOMO: Oh, thank you. Thank 10 you, Ms. Moncada. 11 So any other matters to discuss? 12 MS. BROWNLESS: Since FIPUG and FRF have asked 13 to be excused, is it appropriate to rule upon that 14 at this time? 15 COMMISSIONER PASSIDOMO: I believe I can do 16 that, yes. So, I mean, at this -- we will go ahead 17 and say that FRF and FIPUG will be excused from the 18 March 26th hearing. 19 MR. MOYLE: Thank you. 20 MR. WRIGHT: Thank you. 21 COMMISSIONER PASSIDOMO: Yep. 22 Well, I just want to say thank you all Okav. 23 for all your hard work on this.
