### TAMPA ELECTRIC COMPANY'S NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

Tampa Electric Company ("Tampa Electric" or the "company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006(3)(a), Florida Administrative Code, hereby files this Notice of Intent to Request Confidential Classification for its response to OPC's First Request for Production of Documents (Nos. 1-30), Request No. 3. After working with OPC, the company hereby submits its response to Request No. 3. Portions of this response constitute "proprietary confidential business information" as defined in Section 366.093, Florida Statutes. This response is subject to a pending Motion for Temporary Protective Order filed with the Commission on April 11, 2024.

Pursuant to Rule 25-22.006(3)(a) and (d), Florida Administrative Code, Tampa Electric respectfully requests confidential handling of the material identified in Exhibit A, which is comprised of the company's response to Request No. 3 in OPC's First Request for Production of Documents (Nos. 1-30), while the company reviews that material, identifies which components constitute proprietary confidential business information, and prepares a Request for Confidential Classification.
