### Heather Hills Utilities, LLC

Section 367.081(8), Florida Statutes, requires that rate case expense be recovered over a period of four years. The statute further requires that the rates of the utility be reduced immediately at the conclusion of the four years by the amount of rate case expense previously included in the rates.

Heather Hills Utilities, LLC was granted a rate increase by the Florida Public Service Commission in Order PSC-2020-0119-PAA-WS, in Docket No. 20190113-WS. The four-year recovery period for rate case expense will expire on June 12, 2024. Effective June 13, 2024, the rates will be reduced as follows:
