SECTION 1 – TECHNICAL TERMS AND ABBREVIATIONS

Access Line – A transmission path between user terminal equipment and a switching center.

Central Office – A location where there is an assembly of equipment that establishes the connections between subscriber access lines, trunks, switched access circuits, private line facilities, and special access facilities with the rest of the telephone network.

Customer – The person, firm, corporation or other entity which orders service and is responsible for payment of charges due and compliance with the GRUCom's tariff regulations.

Exchange – The entire telephone plant and facilities used in providing telephone service to subscribers located in an exchange area.

Tandem - Pertaining to an arrangement or sequencing of networks, circuits, or links, in which the output terminals of one network, circuit, or link are connected directly to the input terminals of another network, circuit, or link.

Trunk - a line that carries multiple voice or data channels between two telephone exchange switching systems. In digital communications, a trunk is often a line in an E-carrier system or a T-carrier system.
