REVISED ORDER ESTABLISHING PROCEDURE

Topeka Group, Inc., filed a Motion for Extension of Time (the Motion) on June 23, 1989, requesting that it be given until July 5, 1989, to file its prefiled direct testimony in this matter. Order No. 21414, issued June 19, 1989, required that Topeka Group, Inc., as the applicant, file such testimony by June 27, 1989. Topeka Group, Inc.'s Motion stated that this date did not give it enough time to prepare and file its testimony.

The Office of Public Counsel (OPC) filed its Citizens' Response to Topeka Group, Inc.'s Motion for Extension of Time (the Response) on June 29, 1989, stating that it did not object to Topeka Group, Inc.'s request for an extension of time. However, OPC requested that the overall time schedule be adjusted to give all parties adequate time to perform the activities necessary for this proceeding. We find these requests to be reasonable and, therefore, the dates set out in Order No. 21414 for the key activities in this proceeding are hereby revised as follows:

Revised Controlling Dates

- 1) A preliminary list of issues shall be filed by each party, and may be filed by Staff, on or before Wednesday, August 2, 1989.
- 2) A first informal preliminary prehearing conference shall be held at 2:00 p.m., Friday, August 4, 1989, in Room 122, the Fletcher Building, 101 East Gaines Street, Tallahassee.
- 3) Prefiled direct testimony and exhibits shall be filed on or before the following dates:

Applicant - July 5, 1989  
Intervenors - August 3, 1989  
Commission Staff, if any - August 9, 1989

6) A second informal preliminary prehearing conference shall be held at 9:30 a.m., Wednesday, August 18, 1989, in Room 122, the Fletcher Building, 101 East Gaines Street, Tallahassee.

7) The prehearing conference shall be held at 9:30 a.m., Monday, August 21, 1989, in Room 122, the Fletcher Building, 101 East Gaines Street, in Tallahassee.

8) The formal hearing shall be held on August 30 and 31, 1989, at a time and location to be determined.
