ORDER ACKNOWLEDGING WITHDRAWAL
OF NOTICE OF INTENT TO ABANDON

BY THE COMMISSION:

PPW Sewer Company, Inc. (PPW or utility) is a Class C utility which provides wastewater service to approximately 713 customers in Pasco County. Water service is provided to these same customers by an affiliate, PPW Water Company, Inc. According to its 1987 annual report, the latest on file with the Commission, PPW collected gross annual revenues of \$63,036 for water and \$55,297 for wastewater, and realized net incomes of \$16,149 and \$7,827 for water and wastewater, respectively.

On July 17, 1989, PPW served notice of its intent to abandon its wastewater system pursuant to Section 367.165, Florida Statutes. According to PPW, its notice was precipitated by problems with the Department of Environmental Regulation over the utility's disposal of treated effluent from its wastewater plant.

Since serving notice, PPW has made several attempts to sell the wastewater system. Consequently, it has also extended the effective date of its abandonment several times. Currently, it is expected that either PPW or the subsequent owners will interconnect with Pasco County in November or December, 1990.

Since it appears that a sale is imminent, PPW officially withdrew its notice by letter dated May 25, 1990. Accordingly, by this Order, we acknowledge the withdrawal of PPW's notice of abandonment.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
