CONFIDENTIAL CLASSIFICATION


Pursuant to Florida Administrative Code Rule 25-22.006(3)(a), Florida Power & Light Company ("FPL") hereby provides notice of its intent to request confidential classification for the document to be provided in response to the Office of Public Counsel's request for a late-filed exhibit (Late-Filed Exhibit No. 4) to the deposition of G. R. Cepero, taken on November 28, 1990. The document is the Agreement Between Georgia Power Company and Mingo Logan Coal Company for the Sale and Purchase of Coal. In addition, FPL intends to request confidential treatment of a document it is producing in response to Request No 9 in Public Counsel's Second Request for Production of Documents. This document is entitled "Florida Power & Light Company, Capacity RFP Evaluation Process", and is dated January 1990. It is FPL's belief that the documents requested contain propriety confidential business information and should be exempt from public disclosure. To maintain continued confidential handling of the material during


