Subject: Docket No. 910072-WU, Application for a Limited Proceeding
Rate Increase in Volusia County.

We are in receipt of your application and several deficiencies have been noted. These deficiencies must be corrected before the application can be processed.

1. Filing Fee - Section 367.0822(2), Florida Statutes requires that an application for a limited proceeding must be accompanied by a filing fee. Our Engineering Bureau has determined the filing fee to be \$150 in accordance with Section 367.0822(2), Florida Statutes.

2. DER Notice or Order - Provide a copy of the DER Order, Ordinance, or other evidence which requires the utility to install the generator, seal the well, and any other work performed.

3. Calculation of Increase in Annual Revenue - The utility needs to provide a calculation of the increase in revenue the utility is seeking. This calculation should provide a detailed breakdown of each component of the increase, ie a return on the additional plant investment (specify the rate of return being requested and provide the calculation), depreciation expense on the new plant additions, and increased taxes (regulatory assessment fees on the additional revenue as well as increased property taxes). In calculation of the additional return on the new investment, the utility must use its last authorized rate of return authorized by this Commission.

4. Revised Tariff Sheets Reflecting New Rates - Once the increase has been calculated, the percentage increase should be applied to the existing rates to determine the new rates being requested by the utility. Revised tariff sheets must


