> Re: Notice of Change of Ownership of assets of Miller Gas Company and of Natural Gas Service to Former Miller Gas Customers

Dear Mr. Tribble:

Pursuant to Fla. Admin. Code Rule 25-9.044, this letter will serve as notice to the Commission of a change of ownership or control of the assets of Miller Gas Company ("Miller Gas"), a Commission-regulated natural gas distribution company. City Gas Company of Florida ("City Gas" or "the Company"), the Florida operating division of Elizabethtown Gas Company, acquired all of the natural gas assets of Miller Gas Company effective February 19, 1991 ("the transfer date") and has assumed the obligation to serve all of the retail customers of Miller Gas as of the transfer date.

This will further notify the Commission that City Gas hereby adopts, ratifies and makes its own all rates, rules, classifications and regulations of Miller Gas on file with the Commission and effective as of the transfer date.

Pursuant to Fla. Admin. Code Rule 25-9.044(3), City Gas is simultaneously filing a petition to the Commission for authority to utilize City Gas' Commission-approved rates, rules, classifications and regulations in lieu of the Miller Gas provisions hereby adopted. It is City Gas' intent to apply the Miller Gas tariff on an interim basis pending final disposition of the Company's petition to apply its own tariff in lieu thereof. As is more fully described in the Company's petition, application of City Gas' Commission-approved tariff on a uniform basis with respect to all customers served by the Company, including those customers heretofore served by Miller Gas, will effect a fair and reasonable result and avoid customer confusion.

The Miller system will be connected to the City Gas system within a few weeks, or as soon as possible, and at that time we will have a common gas cost for all our natural gas customers, new and old. For this reason, we will be filing a single WACOG calculation for March billings for City Gas customers and former Miller customers alike, effective March 1, DRAMMENT NUMBER-DATE

Be assured, however, that we will continue applying the Miller PGA true-up factor to Miller's former customers until such time as authority is granted to roll this in to City Gas' PGA true-up. In any event, we are requesting that the PGA true-up liability of each company be combined effective April 1, 1991, which is the beginning of the next true-up period.
