In staff's letter dated February 28, 1991, we requested that the applicant "Provide the First, Second, Third, and any other Amendments, all Exhibits, including Exhibit C (the Pasco County letter), and any other attachments to the Purchase and Sale Agreement, as required by Rule 25-30.037(1)(g), Florida Administrative Code" for the above-referenced docket. On March 20, 1991, we received your response to the request which included several exhibits, amendments and the Assignment of Purchase and Sale Agreement, however we have not received Exhibit C (the Pasco County letter). This document was referenced in Paragraph (o), Page 17 of the Purchase and Sale Agreement and must be filed since it is part of the contract for sale, pursuant to Rule 25-30.037(1)(g), Florida Administrative Code.

Also, Exhibit D of the application, the Statement of Assets and Liabilities, is incorrect. The total assets are shown to be \$2,678,897, however, a recalculation of the assets provided in the statement results in total assets of only \$445,200. The Statement of Assets and Liabilities does not support the allegation that the transferee has the financial ability to provide service. Please provide accurate copies of this and any other financial statements of all entities which have provided or will provide funding.
