REQUESTING EXTENDED SERVICE AREAS FOR
CERTAIN AREAS IN PUTNAM COUNTY

WHEREAS, the Putnam County Board of County Commissioners has been requested by numerous citizens to establish toll free calling services to the Palatka exchange for areas in Putnam County which are now long distance, and

WHEREAS, the Board realizes that Palatka businesses serve the majority of the citizens residing in the Crescent City, Johnson, Orange Springs and Melrose areas, and

WHEREAS, the Board of County Commissioners further realizes that these citizens must absorb a toll call every time they handle necessary daily business as they cannot obtain such services locally, and

WHEREAS, the Board of County Commissioners feels it would be in the best interests of the citizens residing in the Crescent City, Johnson, Orange Springs and Melrose areas to provide toll free exchanges to the Palatka exchange area.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners, Putnam County, Florida, in their meeting assembled on April 9, 1991, that the Florida Public Service Commission, by adoption of this resolution, is hereby requested to consider approving an extended service area for the Crescent City, Johnson, Orange Mills and Melrose exchanges to the Palatka exchange area.

BE IT FURTHER RESOLVED that a copy of this resolution be hereby authorized to be sent to the Florida Public Service Commission.
