SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S
MOTION FOR EXTENSION OF TIME

COMES NOW Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), pursuant to Rule 25-22.037, Florida Administrative Code, hereby moves the Florida Public Service Commission ("Commission") for a thirty-day extension of time in which to file traffic studies in the above-referenced docket, and as grounds therefore states:

1. Commission Order No. 24208, issued on March 8, 1991, directed Southern Bell to prepare and submit traffic studies of routes between Bradford County and Union County by May 7, 1991. As explained below, Southern Bell was not able to complete the traffic studies by May 7, 1991 and therefore is requesting an extension of time to complete the studies.

2. Because of a limitation in Southern Bell's computer system, Southern Bell was not able to prepare the Bradford County and Union County traffic study within the time frame permitted by Order No. 24208. When Southern Bell received Order No. 24208, Southern Bell was using its computer system to develop the Gilchrist County and Deland County traffic studies. See Docket No. 870790-TL and Docket No. 910029-TL. Because Southern Bell was using its computer system to perform these two studies,

Southern Bell was not able to begin preparing the Bradford County and Union County studies. On April 24, 1991, Southern Bell completed the Gilchrist County and Deland County traffic studies and subsequently initiated the development of the study required by Order No. 24208. Southern Bell expects the Bradford County and Union County studies to be completed on or before June 6, 1991.

3. The requested extension will not prejudice any party to this proceeding and will facilitate a reasoned, informed decision by this Commission.

WHEREFORE, Southern Bell Telephone and Telegraph Company respectfully requests that the Commission grant it a thirty-day extension until June 6, 1991, in which to respond to Order No. 24208.
