APPLICATION FOR TRANSFER OF CUSTOMERS



Florida Power & Light Company (hereinafter FPL) and Peace River Electric Cooperative, Inc. (hereinafter PRECO) hereby jointly apply to the Commission for approval of a transfer of customers pursuant to Commission Order No. 18332, dated October 22, 1988, which approved and adopted the FPL-PRECO Territorial Agreement. In support of this Application the parties further state:

- 3. Applicant Florida Power & Light Company is a "Public Utility" incorporated in the State of Florida. Applicant Peace River Electric Cooperative, Inc., is a "Cooperative" organized and existing pursuant to Chapter 425, F.S. Applicants are subject to the Commission's jurisdiction as set forth in Section 366.04, F.S.
- 4. Section 6 of the FPL-PRECO Territorial Agreement, Commission Order No. 18332, is as follows:
  - Section 6 Elimination of Overlapping Services. FPL and PRECO agree to use reasonable efforts to eliminate, during the term of this Agreement, electric services by either party in the retail service areas of the other party. This effort shall include the identification of potential customer and facilities transfers which would eliminate duplication of facilities or avoid hazardous conditions. Any transfers shall be subject to review and approval by the Florida Public Service Commission.
- 5. FPL and PRECO jointly request the approval of the transfer of
  12 PRECO customers to FPL pursuant to Section 6 of the FPLPRECO Territorial Agreement. The customers and their
  addresses are identified in Attachment A hereto. The location
  of the customer's meters and the FPL-PRECO territorial
  boundary are identified in Attachment B.

- 6. This transfer will eliminate electric service to the identified customers by PRECO in FPL's service area and eliminate the duplication of facilities by the utilities.
- 7. There will be no transfer of facilities. PRECO will remove its facilities supporting the identified customers after those customers are connected to FPL's facilities. There will be a service disruption of short duration (less than one hour) to these customers associated with the exchange of services and meters.
- 8. Each customer has been contacted and the difference in FPL and PRECO's rates explained. No opposition to the transfers by the affected customers has been received by either utility.
- 9. The transfer will be scheduled to be completed within 90 days of Commission approval of this Application.
- 10. FPL and PRECO represent that the proposed transfer is in the best interest of the public.

Wherefore, FPL and PRECO respectfully request approval of the proposed transfer of customers.
