3. In this docket the Commission will review the revenue requirements of Southern Bell Telephone and Telegraph Company ("Southern Bell") and will also review Southern Bell's rate stabilization plan.

4. In the course of this review, the Commission will analyze the rates and charges of Southern Bell. FIXCA members provide interexchange service within Florida. As interexchange carriers, FIXCA members pay access charges to Southern Bell. Therefore, FIXCA's substantial interests will be affected by any Commission decision on Southern Bell's rates and charges.

5. In this docket the Commission will also determine whether certain extended area service plans should be implemented, including EAS plans between the Fort Lauderdale, Hollywood, North Dade, and Miami exchanges. As providers of long distance services along these and other proposed EAS routes, FIXCA's substantial interests will be affected by the Commission's decision on such routes.

WHEREFORE, FIXCA requests the Commission to enter an order authorizing it to intervene and participate as a full party in the above proceeding.
