NOTICE OF INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and files, pursuant to Rule 25-22.034, Florida Administrative Code, and Rule 25-22.006(3)(a), its Notice of Intent to Request Confidential Classification.

BACKGROUND

1. On June 1, 1992 the Florida Public Service Commission Staff ("Staff") served its Second Request for Production of Documents on Southern Bell in this docket.

2. On July 6, 1992 Southern Bell filed its Response and Objections to Staff's June 1, 1992 requests. The documents sought by Staff had already been produced for Public Counsel in response to Public Counsel's First Request for Production of Documents, and certain documents were already subject to a pending Motion for Temporary Protective Order filed by Southern Bell on April 24, 1992 relating to such documents.


3. Thereafter, Southern Bell produced six (6) boxes of responsive documents for Staff's inspection at its Company offices in Tallahassee, Florida. The Staff reviewed these documents on Company premises and now requests that Southern Bell provide copies of certain specific documents to Staff.

4. Certain documents requested by Staff clearly contain proprietary confidential business information. For example, the documents contain intraLATA toll market analyses, other market and competitive analysis, strategic planning information, and business planning information. Such information is specifically considered to be proprietary confidential business information pursuant to § 364.183, Florida Statutes.



Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Specified Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to take possession of this information without delay.
