7. Some of the information contained in the responsive documents to be reviewed by the Staff is clearly proprietary. For example, some of the documents and data contain information on, among

Consequently, because these documents contain proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review these documents without delay. The original of this Notice and copies of the staff requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information.
