The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth in conjunction with the above-captioned docket, requesting, among other things, that Southern Bell make available for viewing the following information:

Audit Request No. 3-007, dated October 26, 1992 - computation of the revenue sharing factor to determine the publishing fee for each state, including supporting workpapers and documentation.

Audit Request No. 5-005, dated October 26, 1992 - For 1990, 1991, and budgeted 1992, identify for each department of BellSouth Corporation the number of employees; the total operating expense by account; salary and wages expense; amount of cost billed and cost retained to each of the subsidiaries; and the amount of cost charged to the regulated operations and non-regulated operations.

Some of the information to be reviewed by the Staff is clearly proprietary. Included is information relating to every facet of Southern Bell's business, including its competitive interests. Any competitor or potential competitor of Southern Bell's non-regulated services would desire this information to allow the targeting of lucrative markets. If this were to occur, Southern Bell's revenues could well be diminished which would work to the ultimate detriment of Southern Bell's ratepayers.


