COMES NOW BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and files its Notice of Intent to Request Specified Confidential Classification.

The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth in conjunction with the above-captioned docket, requesting, among other things, that Southern Bell make available for viewing the following information:

(a) Audit Request No. 1-031.A, dated May 11, 1993 - provide the work programs/packages, as discussed by John Mast in our April 26, 1993 interview, for each project performed in the S & T organization for 1992.

Some of the information requested by the Staff is clearly proprietary. For example, the information requested contains strategic planning and market planning information relating to Southern Bell's competitive interests. This information is specifically considered to be proprietary confidential business information pursuant to Section 364.183(3)(e), Florida Statutes.

Because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Specified Confidential Classification, pursuant to Rule 25-22.006(3)(a)(b)(5), Florida Administrative Code, in order to allow the Staff to review this information without delay. The original of this notice has been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Request is attached hereto.
