Issue 2: Recommendation that, if Issue No. 1 is approved, Docket No. 930580-TL should be closed at the end of the protest period. If the tariff is protested, it should go into effect on August 10, 1993, with any increase in revenue held subject to refund.

Issue 3: Recommendation that the effective date of the alarm portion of the repricing and restructuring of GTEFL's local private line service (Docket No. 910967-TL) should be April 1, 1994 and should reflect Phase I rates. If a timely protest is filed, this tariff should remain in effect with any increase in revenue held subject to refund pending resolution of the protest.
