COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25-22.034, Florida Administrative Code, and Rule 25-22.006(3)(a), files its Notice of Intent to Request Confidential Classification.

1. On November 8, 1993, the Office of Public Counsel ("Public Counsel") filed the testimony of its witnesses in the above captioned docket. The testimony and exhibits of Thomas C. DeWard, Kimberly H. Dismukes, and R. Earl Poucher were filed by Public Counsel under protective seal. This was due to the fact that much of the information contained in the testimony and exhibits was based upon responses by Southern Bell to various interrogatories and production of document requests by Public Counsel, many of which were the subject of Motions for a Temporary Protective Order.

2. Some of the information contained in the testimony and exhibits of Messrs. DeWard and Poucher and Ms. Dismukes is entitled to proprietary confidential classification because it includes, among other things, information concerning unregulated services and entities, and the findings of internal audits. This information is clearly confidential and proprietary under Florida
