SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S NOTICE  
OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission has issued a Florida PSC Audit Request to Southern Bell dated April 18, 1995. Staff requests, among other things, that Southern Bell furnish the following information:

2. Request No. 1 - "List of all internal audits re: coin telephones CFR 93, 94 and 95."

3. Request No. 2 - "All internal audit reports re: set use fee of 25 cents for 1993, 1994 and 1995."

4. Request No. 3 - "Meeting with programmer or anyone responsible for the set use fee calculation to explain how the system works, the program, how SBT records set use fee calls of 0+ and 0- calls, how calculated set use fee, how billed to IPP."

5. Request No. 4 - "Sample invoice of an IPP showing the set use fee credit and SBT itemized detail calculating the credit. Any month in 1994 and any company."

6. Request No. 5 - "Print out from code for PICS and set use fee program."

7. Request No. 6 - "Detail of set use fee true ups for the period of February 1993 through February 1994 and the period March 1994 through April 1995 or May 1995. Also an explanation of the true up from the person or persons responsible and why the true up had to be made."

8. The information requested includes customer specific information, confidential business information and internal audit reports which are clearly proprietary. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3), (3)(b), (3)(c) and (3)(e), Florida Statutes.

9. Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on

the Division requesting the information. The written Staff requests are attached hereto.
