ORDER GRANTING AQUARINA DEVELOPMENT, INC.'S
MOTION FOR EXTENSION OF TIME
AND
REVISING ORDER ON PROCEDURE

On January 3, 1996, this Commission issued an Order Establishing Procedure (Order No. PSC-96-0009-PCO-WS) which established requirements for discovery, filings, notice, testimony and exhibits, prehearing statements, prehearing conference, waiver of issues, document identification, controlling dates, the use of confidential information and post-hearing procedures. According to that Order, Aquarina Developments, Inc.'s (Aquarina or utility) testimony was due January 26, 1996.

On January 12, 1996, Aquarina, moved for a twelve-day extension of time in which to file its direct testimony and exhibits. In support of its motion, Aquarina states that it lacked sufficient time in which to file its testimony and exhibits. Aquarina provided copies of its motion to all parties. Parties did not file an objection to Aquarina's motion.

In consideration of the above, Aquarina's motion is granted. In order to allow time for Aquarina to file its testimony, and to provide all other parties and Staff the same amount of additional time in which to file testimony due subsequent to Aquarina's deadline, the following dates shall control in this docket:


