SECOND ORDER MODIFYING PROCEDURAL SCHEDULE

On April 4, 1997, following the testimony by the last witness in this case, the hearing was recessed in order for the Commissioners to conduct a field visit to inspect the facilities of Gulf Power Company (Gulf Power) and Gulf Coast Electric Cooperative, Inc. (Gulf Coast) in Bay and Washington counties. At that time, it was uncertain whether an additional hearing day would be required following the field visit. At the conclusion of the June 18, 1997, field visit, all parties agreed that additional testimony was not required; therefore, the record in these proceedings was closed. It is now necessary to establish a briefing schedule for the parties to file their post-hearing statements. The transcript of the field visit was filed with the Commission's Division of Records and Reporting on June 23, 1997, and the transcript of the technical hearing was filed on May 8, 1997. The parties have mutually requested, because of their current commitments, that the post-hearing statements be filed on August 25, 1997.

Upon consideration, it is found that the request is reasonable and shall be granted. Accordingly, Gulf Power and Gulf Coast shall file their post-hearing statements on Monday, August 25, 1997.

Based on the foregoing, it is

ORDERED by Commissioner Susan F. Clark, as Prehearing Officer, that post-hearing statements shall be filed on August 25, 1997. It is further

ORDERED that the Order Establishing Procedure, Order No. PSC-96-0466-PCO-EU, issued April 3, 1996; and Order Modifying Procedural Schedule, Order No. PSC-96-1274-PCO-EU, issued October 11, 1996, are reaffirmed in all other respects.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of

Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
