MCI), pursuant to Rule 25-22.039, F.A.C., hereby petition the  
Commission to allow them to intervene in this proceeding. In

3. MCIT is certified by the Florida Public Service  
Commission as an interexchange carrier (IXC) and as an  
alternative local exchange telecommunications company (ALEC).  
MCIT currently provides interexchange service to customers within  
the State of Florida. MCImetro is certified by the Florida  
Public Service Commission as an ALEC. MCImetro has begun

providing local exchange telecommunications services to business customers within the State of Florida.

4. MCI participated as a party in the proceeding in which the previous relief plan for the 305 area code was adopted. As a provider of domestic and international long distance service, MCIT's interests are affected by any area code relief plan that may impact its long distance operations. As a code holder in the 305 NPA, MCI metro is also affected by any area code relief plan that may be adopted.

WHEREFORE, MCI respectfully requests that it be given leave to intervene as a party to this proceeding.
