AMENDATORY ORDER

BY THE COMMISSION:

On October 17, 1997, we issued Order No. PSC-97-1293-FOF-TP in the above mentioned Docket. The Order granted approval of an interconnection, resale, and unbundling agreement between the above listed entities. Due to a scrivener's error in the caption and the body of the Order, however, the name of National Telecommunications of Florida, Inc. d/b/a NationalTel was incorrectly stated as National Telecommunications, Incorporated.

Further, since the issuance of Order No. PSC-97-1293-FOF-TP, it has come to the Commission's attention that National Telecommunications of Florida, Inc. d/b/a NationalTel is in fact certificated to provide Alternative Local Exchange Services in Florida under Certificate Number 4447.

Therefore, Order No. PSC-97-1293-FOF-TP, is amended to correctly state the name of National Telecommunications of Florida, Inc. d/b/a NationalTel. Additionally, the sentence in the body of Order No. PSC-97-1293A-FOF-TP stating that National Telecommunications of Florida, Inc. d/b/a NationalTel is not certificated in Florida and may not provide service until it receives a certificate shall be deleted. The ordering paragraph that similarly directs the company to request and receive a certificate before it provides telecommunications service shall also be deleted.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-97-1293A-FOF-TP is hereby amended to reflect the name of National Telecommunications of Florida, Inc. d/b/a NationalTel. It is further
